This form is also used for travel expenses incurred by those working in a special field, such as construction, civil engineering or forestry. You can deduct the expenses for travelling between your home or second home and a specific job site as expenses incurred in acquiring or maintaining income, if your job site changes frequently due to the short-term nature of your work, or if your job site is not in a fixed location. The deduction is conditional on your employer not having paid you any travel allowance.
Do not attach any receipts or free-form clarifications to the form; place them somewhere for safekeeping. The Tax Administration will ask you for the receipts, if necessary
