Complete this form if you need to get a statement in order to have a transfer of title, a transfer of lease rights or a transfer of other special rights registered by the authorities. You can request a statement if a transfer tax must be paid and reported on a tax return. You can also request a statement on how much tax must be paid and on how much the fair market value is on property. You may need this e.g. for an Exchange of property deal. Statements are not given until after the contract has been finalised and signed. Each buyer must make a separate request for a statement.

Instructions for requesting a statement

To process your request, the Tax Administration will need a photocopy of the deed of sale (or other contract) with the appropriate signatures. If real property had been transferred, the contract must additionally contain a public purchase witness's signature. Enclose copies of other relevant documentation regarding the transfer.

Do not forget to sign this request and to fill in your contact information.

If you have a representative who will answer questions regarding this request, or if the Tax Administration should send the statement to a representative, fill in the representative's name, telephone and address. Enclose the representative's power of attorney. It may be provided as a free-text letter, or on Form 3818e (Letter of Authorisation for Tax Representation).

Send the completed request form with enclosures to the Finnish Tax Administration – Verohallinto, P.O. Box 700, 00052 VERO. Alternatively, you can hand deliver it to any office of the Tax Administration.

We will send the statement to you by post after processing your request. It will also be available in MyTax. When you prepare an application for registration of title or other legal confirmation, you must enclose the Tax Administration's statement (unless you ticked the "Yes" box above in section 3 to request the Tax Administration to send the statement directly to the National Land Survey).
